I. SCOPE OF SOLICITATION

ACQUIRE SUPPLIES / EQUIPMENT (Modified)

The purpose of this solicitation is to establish a source or sources of supply for the purchase of educational supplies which provide tools that help children reinforce and support learning.

The following items will necessarily be **EXCLUDED** from the contract:

- Furniture
- Science Laboratory fixtures and equipment, i.e. plumbing fixtures, hoods, filtration, technology applications
- Information technology/data fixtures featuring or facilitating technology applications or software
- Used, remanufactured or refurbished products
- Items within other State Term Contracts such as Office Supplies, Paper, Science Education Supplies, etc.

MAXIMUM CONTRACT PERIOD - ESTIMATED (Modified)

Start date: 04/07/2021 End date: 04/06/2026. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period".

The initial term of the contract will be one (1) year, and there will be four (4) one-year options to renew for a maximum contract life of five (5) years.

II. INSTRUCTIONS TO OFFERORS - A. GENERAL INSTRUCTIONS

AUTHORITY means the State Fiscal Accountability Authority or its successor in interest.

BUSINESS means any corporation, partnership, individual, sole proprietorship, joint stock company, joint venture, or any other legal entity. [11-35-310(3)]

CHANGE ORDER means any written alteration in specifications, delivery point, rate of delivery, period of performance, price, quantity, or other provisions of any contract accomplished by mutual agreement of the parties to the contract. [11-35-310(4)]

- Items within other State Term Contracts such as Office Supplies, Paper, **Science Education Supplies**, etc.

Published books, periodicals, and technical pamphlets are exempt from the Procurement Code, as well as some Copyrighted Educational Materials listed [here](#). Books are categorized as educational supplies. Early Childhood & Elementary Educational Supplies are items that districts might need to facilitate tracking of student learning overall and assessments as outlined in subject academic standards from the SC Dept of Education.

Instructional Supplies – Middle and High School levels - This category represents core subjects including English Language Arts, Mathematics and Science and Social Studies. Examples include manipulatives, magnifiers, safety goggles, thermometers, scales, teaching resources, subject practice assessments, or supplies that allow students to explore an idea in an active, hands-on approach. Requests from Districts/Schools could include items such assignment planners, magnets, or as well as adult size headphones, or science-related kit/packets and goggles that are not part of existing related contracts. Items listed for Instructional Supplies represent a small list items that districts might need to facilitate tracking of student learning and assessments outlined in subject academic standards from the SC Dept of Education.

Physical Education – Middle School level and below - Physical education is part of the school experience of South Carolina students. Physical education provides students with important opportunities for healthy activities and play to develop the knowledge, skills, and confidence to enjoy a lifetime of physical activity. Examples include, but are not limited to, jump ropes, basketball, football, soccer, badminton, table tennis, and volleyball. These examples represent some items that districts might need to facilitate tracking of student learning and assessments outlined in academic standards from the SC Dept of Education.

Art Education - This category represents educational supplies as they relate to art education. Examples include crayons (standard/jumbo size), various paints (finger, acrylic, watercolor, oil, pastel, etc), various paper (construction, drawing, etc) or supplies that allow students to explore an idea in an active, hands-on approach. Requests from Districts/Schools could include items such washable ink, stamp pad, various shaped and sized paintbrushes, pipe stems, tissue paper, or various sized paper rolls. Art Supplies are items that districts need to facilitate tracking of student learning overall and assessments as outlined in academic standards from the SC Dept of Education.

OFFERS LESS THAN 15 PERCENT DISCOUNT FROM THE CONTRACTOR'S CATALOG PRICE WILL BE REJECTED.

PAYMENT & INTEREST (FEBRUARY 2021)

(a) The State shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government. (b) Unless otherwise provided herein, including the purchase order, payment will be made by electronic funds transfer (EFT). See clause titled "EFT Information." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other

than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-4]

PUBLICITY (JAN 2006)

Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006)

Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

SURVIVAL OF OBLIGATIONS (JAN 2006)

The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

TAXES (JAN 2006)

Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by the State to contractor, contractor shall be liable to the State for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006)

Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefor. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY (JAN 2006)

This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. [07-7A090-1]

WAIVER (JAN 2006)

The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract,

by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

VII. TERMS AND CONDITIONS -- B. SPECIAL

CHANGES (JAN 2006)

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

CONTRACT LIMITATIONS (JAN 2006)

No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

DEFAULT (JAN 2006)

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

PRICE ADJUSTMENTS (JAN 2006)

(1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

- (a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
- (b) by unit prices specified in the Contract or subsequently agreed upon;

Code of Laws.

(2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

This is a firm fixed price term contract. It is the intent of the Materials Management Office to maintain the percent discount being offered for the full initial term (1 year) plus the four (4) option terms (also 1 year). Offerors are encouraged to secure pricing from the manufacturers accordingly. The price adjustment clause is included so the Materials Management Office may consider a price increase in highly unusual market conditions. In the absence of highly unusual market conditions, the State intends to hold the originally awarded discount percentage flat throughout the maximum five (5) year life of the resulting contract. As an exception, the State will consider a price adjustment when the vendor is submitting an updated product for consideration under the CONTRACT PRODUCT CHANGES clause in Section III for items contained in the market basket.

Each Using Governmental Unit's obligations and liabilities are independent of every other Using Governmental Unit's obligations and liabilities. No Using Governmental Unit shall be responsible for any other Using Governmental Unit's act or failure to act. [07-7B210-1]

SHIPPING / RISK OF LOSS (JAN 2006)

F.O.B. Destination. Destination is the shipping dock of the Using Governmental Units' designated receiving site, or other location, as specified herein. (See Delivery clause) [07-7B220-1]

STATEWIDE TERM CONTRACT (DEC 2015)

(a) With this solicitation, the state seeks to establish a term contract (as defined in Section 11-35-310(35)) available for use by all South Carolina public procurement units (as defined in Section 11-35-4610(5)). The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.
- (4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.
(b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;
(c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor

the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:

- (i) contract prices for supplies or services accepted under the contract;
- (ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;
- (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;
- (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.
- (d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.
- (5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the State's right to require the termination of a subcontract, or (ii) increase the obligation of the State beyond what it would have been if the subcontract had contained an appropriate clause.

1. Can the proposal be digitally signed by the supplier or must the document be hand signed?

State's Response: *No change. Page 1 of the solicitation must include a handwritten signature. The State does not accept electronically signed documents at this time.*

2. If we submit our bid response online, should we submit a paper copy of the catalog via mail or submit a digital version of our catalog online? I do realize that we will also be noting our website address on the contract, but I also would think you should have a printed catalog or a digital version of that catalog submitted with our response. Without a printed version of the catalog, you will not have anything to reference back to IF a vendor would change pricing online. We can hold our pricing without a problem, but having a printed catalog submitted with the vendor response would help assure schools that the pricing is correct on the contract.

3. Will we need to furnish catalogs to each school or have a separate website for this contract?

State's Response to Questions 2 & 3: *Please see Scope of Work, Catalogs in the Solicitation. The State does not maintain price lists or catalogs. Do not supply printed product literature, specifications, catalogs, brochures with your bid. Product photographs, descriptions, specifications, and price lists shall be available and easily accessible on-line and provide an adequate basis for determining the quality and function capabilities of the educational supplies offered. Refer to the paragraph entitled "Catalogs" in Section III.*

4. **On page 18, Delivery Costs – Exemption, Individual orders under \$50 may be billed shipping. We carry specific products that are considered overweight or oversized by parcel carriers or are drop-shipped by the supplier. While the furniture exclusion will eliminate many of these items, we do have equipment and specific products that would still be included in contracted product. Would shipping exclusions be permitted?**

Below is example language:

Free Freight Exclusions

- **Oversized or heavy weight** items (i.e. paper rolls, linoleum rolls, presses, or any item indicating additional handling)
- 50-lb boxes of **clay** or **ANY modeling material** totaling 50-lbs or greater in weight
- **Drop-ship items** (any item with the letter **F** in the catalog item # prefix or noted as **factory-direct** online)
- When ordering sheets of paper or board larger than 18" x 24" in quantities of less than 10, a per-order handling fee applies. Paper or boards may be assorted to reach the quantity of 10.

5. Is there a place in the vendor response to name the catalog (vendor name, catalog number, catalog year, etc.) the vendor is submitting for the contract? On the contract, you only require the vendor to enter a discount %, but you do not require the vendor to name the Catalog on the contract. So, you would not have a catalog number or year to reference back to, to assure the schools that the correct catalog and year's pricing is being used on the vendor's contract.

State's Response: *Please see Section III. Scope of Work, Catalogs in the Solicitation. The State does not maintain price lists or catalogs. Do not supply printed product literature, specifications, catalogs, brochures with*

your bid. Product photographs, descriptions, specifications, and price lists shall be available and easily accessible on-line and provide an adequate basis for determining the quality and function capabilities of the educational supplies offered. See Section II. Instructions to Offerors – A. General Instructions, Responsiveness/Improper Offers. Also, refer to the paragraph entitled “Catalogs” in Section III.

6. **On page 33, VIII. Bidding Schedule / Price-Business Proposal, it states “offers less than 25 percent discount from the Manufacturer’s List Price will be rejected”. We respectfully suggest this threshold be lowered and terminology adjusted for Lot 4, Art Education Supplies to 20% off supplier’s published catalog price.** Manufacturer’s List Price is not how most art supply providers list catalog base prices. Further, many manufacturers of scholastic art materials do not set an MSRP for their product. Because of this, there is wide variation in discount offers for this commodity such that a 20% discount off one supplier’s catalog is equivalent to 35% off another supplier’s catalog.

Further on the question of discount, are we able to exclude specific product groups or price offers from discount – such as drop shipped items, sale catalogs, website prices? Our website does not reflect catalog price but rather is a daily fluctuating “market price” to serve our non-institutional customer base. Below is example language:

Discount Exclusions

- **Sale catalogs** You will receive the **lower of the sale price or catalog discount** off the “REG” price.
- **Web prices** You will receive the **lower of the web price** at the time of order **or your catalog discount** by placing the discount reference contract code in the discount code box in your shopping cart.

Note: web prices may fluctuate daily.

- **Quantity pricing** You will receive **the lower of the quantity break, for the quantity ordered, or your discount** from the “EACH” price.
- **Drop-ship items** Any item with the **letter F** in the catalog item # prefix or noted as **factory-direct** online.
- **Other** Cannot be used in conjunction with additional **coupons or other promotions.**

7. Is it possible to consider lowering (or removing altogether) the 25% discount requirement for Lot 1 and Lot 2? To ensure students receive the highest quality experience possible, it may be valuable to take into account value-adds and quality of product, as integral parts of the evaluation process. By imposing the minimum requirement, many vendors that offer products in high demand from teachers/students may be unable to participate. A relaxation of this requirement would allow more options for end users, and also ensure that valuable supplemental offerings would reach students.

State’s Response to Questions 6 & 7: *Please see updated Section III. Scope of Work and Bid Schedule.*

8. On page 31, using your example of 65%, can you show me how the Unit Price / Percent Discount and Extended Price sections should be filled out? In your example, would we enter 65.00 in the "Unit Price / Percent Discount" and 65.00 in the "Extended Price" sections?

State’s Response: *Please enter your offered discount in the Unit Price field in SCEIS as a dollar amount. The SCEIS system will multiply the Unit Price by the Quantity (quantity is “1” in this case) and will populate the Extended Price. If you are submitting your bid by scanning the bid schedule into SCEIS, please enter the Unit Price/Percent Discount into both the unit Price/Percent Discount field, as well as in the Extended Price (will be the same as the entered Unit Price/Percent Discount) field.*

9. REDACTED receives special pricing occasionally that we would like to pass on the savings to the schools with this sample market basket list. The prices on the MB would be available to all schools under this agreement and would be updated with new items or price increases annually when the new year catalogs are released.

State's Response: *The State is requesting a discount off of catalog price for this solicitation. If a vendor has a discount that is more advantageous for the State that exceeds the offered discount for the catalog, the vendor should pass the additional savings on to the Using Governmental Unit. The offered and contracted discount is a minimum requirement.*

10. Is page 37 "Purchase Order Attachment - Acceptance of Offers 10% Below Statewide Term Contract Price" a required document that needs filled out or is this just an example of the form we would receive if an agency finds pricing 10% below Statewide Term Contract pricing?

State's Response: *Please see Section VII. Terms and Conditions – B. Special, Statewide Term Contract – Acceptance of Offers 10% Below Price. In the Instructions, there is an explanation as to who completes the form and under what circumstances the form will be used. This is not a form that should be completed outside of the noted circumstances or by vendors contracted as part of the Statewide Term Contract.*
