I. SCOPE OF SOLICITATION

ACQUIRE SUPPLIES / EQUIPMENT (MODIFIED)

The purpose of this solicitation is to make available for purchase Type A-1, 14 Passenger Mini-Buses. These contracts are required to fulfill the requirements of "Jacob's Law" and are designated to replace 15 passenger vans for any entity, whether public or private, who transport school age children to and from public or private school, daycare facilities and churches.

Contracts may be awarded in a manner that no one body manufacturer receives more than two awards, and no one contractor receives more than two awards.

NOTE: This is a statewide contract that carries an administrative fee and is open to any entity in the State who is transporting school-aged children including, but not limited to, State Agencies, political subdivisions, school districts, churches and daycares. It is understood that awarded vendors will pay the administrative fee for ALL sales under the resulting contract and not just those made by someone who would be considered a government entity.

MAXIMUM CONTRACT PERIOD - ESTIMATED (MODIFIED)

Start date: **02/22/2023** End date: **02/21/2026**. Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract - Effective Date/Initial Contract Period".

This is a one (1) year contract with two (2) one-year renewal options. The maximum contract life is three (3) years.

II. INSTRUCTIONS TO OFFERORS - A. GENERAL INSTRUCTIONS

DEFINITIONS, CAPITALIZATION, AND HEADINGS (DEC 2015)

III. SCOPE OF WORK/SPECIFICATIONS

GENERAL REQUIREMENTS

1. This vehicle must meet all applicable Federal Motor Vehicle Safety Standards for use as a School Bus. If there is a conflict between the State's specification and the federal standards referenced above, the federal standards prevail.
2. Vehicle(s) shall meet all applicable and current FMVSS, including requirements of FMVSS #221 defining 60% joint tensile strength for school buses.
3. Vehicle(s) must be less than CDL requirements with a minimum gross vehicle weight rating of 10,000 lbs.
4. Vehicle(s) shall be powered utilizing a V-8 gasoline engine at a minimum.
5. Vehicle(s) bid shall be new current year model only. Acceptable model years for each term of the contract are as follows:
 - Term / Year #1: 2022 or newer
 - Term / Year #2: 2023 or newer
 - Term / Year #3: 2024 or newer
6. Capacity shall be a minimum of 14 passengers with school bus seating.
7. Vehicle shall be mounted on a Dual Rear Wheel (DRW) chassis.
8. Interior Body width shall be a minimum of 90 inches.
9. Wheelbase shall not exceed 159 inches on base units.
10. Delivery to end user shall be included in bid price. Delivery shall be at maximum no more than 180 days from receipt of purchase order. Deliveries will be to any point in the State of South Carolina.

CHASSIS REQUIREMENTS

1. CHASSIS: New current year model is required. Must be school bus certified.
2. GVWR: 10,000 lbs. minimum.
3. ALTERNATOR: 150 amp minimum.
4. FUEL TANK: Minimum of 25 gallons.
5. Four (4) wheel anti-lock brakes are required.
6. BRAKES: Power hydraulic disc brakes are required.
7. TIRES: Six (6) 75R16 minimum 10 ply radial Tires are required. If body will support the safe mounting of a spare tire it shall be included and be the same size as the other tires, and include a jack and lug wrench.
8. A minimum five (5) speed automatic transmission is required.
9. A minimum of one (1) 825 CCA battery is required. Multiple number battery configurations will be considered as long as they meet or exceed the minimum CCA.
10. Heavy-duty cooling package is required.
11. Power steering is required.
12. Intermittent windshield wipers are required.

13. AIR CONDITIONING: Front Dash & Rear - The interior air conditioning system with the capacity to cool both passenger and driver areas a minimum of 20 degrees F when operated in a constant ambient temperature of 100 degrees F with greater than 50% humidity. Performance test results are not required to be provided.

BODY REQUIREMENTS

1. CONSTRUCTION

Body construction shall meet or exceed all requirements of FMVSS #221. Bus body shall be mounted to the chassis using thick rubber isolators between the bus body and chassis. These isolators are used to provide shock relief for the bus body and a smooth ride for the passengers.

Minimum bus body construction requirements are as follows:

Floor: All floor joints shall meet the "joint strength" requirements of FMVSS #221. Floor panels shall be aluminum, galvanized steel or aluminized steel and shall be covered with exterior plywood (either standard treated or marine grade), joined with adhesive contact cement for strength and durability.

All components will be continuous in design that interweave together to eliminate joint fatigue failure.

Provide seat fixture anchors meeting FMVSS #222. Smooth, black OEM standard floor covering shall be installed under passenger seats and in driver area. Ribbed black OEM standard floor covering required in aisle areas. Ribbed with white nosing required on steps. Black molded rubber shall cover the entire right and left wheel housings for durability. The area where floor meets wall shall be rust proof.

Body Side Plate: Body Side Construction to meet Federal requirements for side impact protection and shall be of metal construction, non-composite.

Roof Bows: Roof Bows shall meet FMVSS #220 and be of metal construction, non-composite.

Rear Structure: Shall meet FMVSS #220 and shall be of metal construction.

Interior Sheet Metal: All interior sheet metal shall be installed utilizing pull rivets or sheet metal screws. Interior side panels shall be embossed aluminum.

Roof Caps: Both front and rear roof caps shall be of molded one - piece, reinforced composite fiberglass for best durability.

Rubrails: Three metal rubrails shall be applied to exterior sheet metal; one at window line, one at seat level and another just above floor level. The seat level rail shall extend around rear corner each side then terminate at rear emergency door frame for added strength. All rails shall be designed to facilitate drainage at bottom.

Undercoating: Body and chassis shall be undercoated.

Perforated Acoustical Ceiling Panels: The entire interior ceiling of bus shall be aluminum perforated acoustical headlining. These ceiling panels must be designed and fastened to minimize vibration and must be installed in such a way as to permit easy and unrestricted access to the electrical components located in the ceiling. This acoustical headlining shall be designed to reduce interior noise and add extra insulation to the bus.

2. RIGHT FRONT VISION PANEL

To maximize driver's field of vision, a molded composite fiberglass panel with approximately 330 sq. in. minimum glass area is required at right front ahead of entrance door for superior visibility of oncoming traffic.

3. DOOR/STEPWELL, ENTRANCE

Both door panels of passenger entrance door shall open outward. This door shall provide a minimum clear opening of 24 inches horizontal and 68 inches vertical. Each door panel shall be padded with rubber nosing to protect fingers at closing. Door hinges will utilize sealed ball bearings for ease of operation and durability. Once closed, all door mechanisms shall be inside the bus body for protection. A minimum of 1300 sq. in. glass area required for driver visibility. A bearing-equipped manual door control with over-center locking design and a push release

to prevent accidental opening is required; all door control parts shall be non-glare finish. An electrically operated door may be substituted for the manually operated door as long as it meets all other door requirements. Install a four (4) inch padded header over the door. Entrance stepwell shall have two full width steps covered with ribbed OEM standard floor covering. Require white nosing at step edge and floor where steps terminate. Entire stepwell shall be constructed of aluminum alloy or standard galvanized steel painted black for resistance to corrosion and durability. A driver's entrance door shall be provided by chassis manufacturer.

4. EXITS, EMERGENCY

The primary emergency exit shall be a single door located at rear center of vehicle; door shall have upper and lower glass for visibility meeting FMVSS standards. A retainer to hold door open at 90° is required. Install 5-inch header pad over door. The exterior handle must contain a primer to include a finish paint that will not peel or flake.

Two emergency push-out side windows shall be provided (One per side), with one audible buzzer located in the driver's area/front of bus.

5. HEADROOM

Interior must have minimum of 72 inches' headroom at the aisle. This is to be measured over the 1/2" plywood and floor covering.

6. HEATERS AND DEFROSTER

Front driver heater and defroster are to be supplied by chassis manufacturer. An additional heater shall be installed fully beneath a seat in rear of bus with an isolation valve accessible under the hood.

7. INSULATION

Insulation, minimum of 1 1/2 inches thick, shall be installed in roof and at front and rear of body. The side walls and roof bow cavities must be insulated.

8. LIGHTS AND REFLECTORS

8 – light alternately flashing warning light system is required. Lights shall consist of four (4) red signal lamps and four (4) amber signal lamps mounted in accordance with SAE Standard J887. One or more rows of dome lights will be mounted over aisle in ceiling panels. Two backup lights come on when transmission is in reverse. Two 7-inch amber directional at rear (front supplied by chassis manufacturer). Two amber side directional lights mounted on sides of bus. Three amber front and three red rear mounted marker lights. Clearance lights as required by law. Two stop lights wired to come on when taillights brighten for brake application. Step-well light wired with clearance light switch, comes on when door is opened. One-inch reflective tape framing all emergency exits required. Two 3 inch red reflectors on side near the rear of body and two 3 inch red reflectors mounted on rear.

A self-contained White Strobe Lamp having a minimum rating of ten (10) joules, double flash and a maximum height of six (6) inches. The lamp shall be mounted/located on the roof centerline within thirty-six (36") inches from the rear of bus. The light shall be wired so as to operate with the ignition switch and shall be protected by a circuit breaker so that a short at the lamp will not adversely affect any other component. A protective guard angled from the front shall be designed and installed to allow limbs or low hanging objects to ride over the lamp.

9. MIRRORS

Exterior: Two front cross view mirrors with upper tint to help eliminate glare in the driver's eyes shall be mounted at the right and left front fenders. Two rearview mirrors (one each side of vehicle). The right or passenger side mirror is to be visible through the windshield. The left or driver's side mirror is to be visible through the driver's window. These mirrors shall be oval or rectangle shaped to provide the driver with the best line of sight while still providing a large mirror area to the rear of bus.

Interior: 6 x 16 inch clear safety glass with safety plate glass and rubber padded rounded corners.

10. MUD FLAPS

Front and rear mud flaps shall be provided.

11. PAINT

Interior: Baked enamel – lead free.

Exterior: Shall be OEM, heat cured, polyurethane for best durability – lead free National School Bus Chrome Yellow with three (3) black rub rails, black trim and black rear bumper. All manufacture’s standard colors will also be available for purchase orders that do not require school bus yellow.

12. SAFETY EQUIPMENT

Following are minimum requirements:

- A. 5 lb. dry fire extinguisher with hose mounted in driver’s area.
- B. 10 Unit Ever Ready or equivalent first aid kit and seat belt cutter in driver’s compartment.
- C. Triangular warning devices, mounted in driver’s area.
- D. Body fluid clean – up and blood pathogen kit mounted in driver’s area.
- E. Seat belt cutter mounted in driver’s compartment.
- F. Backing safety alarm.
- G. Front Bumper Mounted Crossing Gate.
- H. Electric Operated Crossing Arm.
- I. Child Reminder Alarm.

13. SEAT, DRIVER

As installed by chassis manufacturer. Shall include lap and shoulder belt for driver.

14. SEATS, PASSENGER

Minimum of 34” School Bus Certified bench Seats shall be installed and shall meet all requirements of FMVSS #222, including criteria for simultaneous pull (15,000 lb./seat). Capacity shall be 14 passengers, two per seat. Seat frames shall be of hi-tensile strength, one-inch tubing. All passenger seats shall be equipped with alternating color lap seat belts for each passenger. Seat frames shall be painted black. School Bus certified Crash barriers shall be installed at right and left front of bus. Upholstery shall be solid color vinyl. If child restraints are requested they will be integrated into the seat.

15. STORAGE COMPARTMENT

A minimum 1,200 cubic inch large storage compartment, with standard OEM interior, shall be located above driver’s area; this to have a hinged door with positive latch stop or prop rod.

16. SWITCH PANEL

Driver's switch panel shall be located within easy reach of driver while seated in the driver’s seat. Panel is to be located to the driver’s right or above the windshield. Switches shall be clearly labeled and illuminated with headlights on so they can be identified easily in most light conditions.

17. WINDOWS

Driver's: Supplied by chassis manufacturer.

Passenger: All windows shall be split sash with aluminum frames. A minimum 12-inch vertical opening is required when upper sash is lowered.

Design shall permit latch replacement without removing window; if window replacement is necessary, easy removal may be from inside or outside.

All side and rear windows will be tinted.

18. WINDSHIELD

One - piece, provided by chassis manufacturer.

DELIVERY/PERFORMANCE LOCATION -- PURCHASE ORDER (JAN 2006)

After award, all deliveries shall be made and all services provided to the location specified by the Using Governmental Unit in its purchase order. [03-3015-1]

EQUAL OPPORTUNITY (JAN 2006)

Contractor is referred to and shall comply with all applicable provisions, if any, of Title 41, Part 60 of the Code of Federal Regulations, including but not limited to Sections 60-1.4, 60-4.2, 60-4.3, 60-250.5(a), and 60-741.5(a), which are hereby incorporated by reference. [07-7A030-1]

FALSE CLAIMS (JAN 2006)

According to the S.C. Code of Laws Section 16-13-240, "a person who by false pretense or representation obtains the signature of a person to a written instrument or obtains from another person any chattel, money, valuable security, or other property, real or personal, with intent to cheat and defraud a person of that property is guilty" of a crime. FIXED PRICING REQUIRED (JAN 2006)

Any pricing provided by contractor shall include all costs for performing the work associated with that price. NOTICE (JAN 2006)

(A) After award, any notices shall be in writing and shall be deemed duly given (1) upon actual delivery, if delivery is by hand, (2) upon receipt by the transmitting party of automated confirmation or answer back from the recipient's device if delivery is by telex, telegram, facsimile, or electronic mail, or (3) upon deposit into the United States mail, if postage is prepaid, a return receipt is requested, and either registered or certified mail is used. (B) Notice to contractor shall be to the address identified as the Notice Address on Page Two. Notice to the state shall be to the Procurement Officer's address on the Cover Page. Either party may designate a different address for notice by giving notice in accordance with this paragraph. [07-7A050-1]

OPEN TRADE (JUN 2015)

During the contract term, including any renewals or extensions, Contractor will not engage in the boycott of a person or an entity based in or doing business with a jurisdiction with whom South Carolina can enjoy open trade, as defined in SC Code Section 11-35-5300. [07-7A053-1]

PAYMENT and INTEREST (FEB 2021)

(a) The State shall pay the Contractor, after the submission of proper invoices or vouchers, the prices stipulated in this contract for supplies delivered and accepted or services rendered and accepted, less any deductions provided in this contract. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government.

(b) Unless otherwise provided herein, including the purchase order, payment will be made by electronic funds transfer (EFT). See clause titled " EFT Information."

(c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off.[07-7A055-4]

PUBLICITY (JAN 2006)

Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006)

Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

SURVIVAL OF OBLIGATIONS (JAN 2006)

The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. TAXES (JAN 2006)

Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. THIRD PARTY BENEFICIARY (JAN 2006)

This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. WAIVER (JAN 2006)

The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

VII. TERMS AND CONDITIONS -- B. SPECIAL

CHANGES (JAN 2006)

(1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.

(2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract.

CONTRACT LIMITATIONS (JAN 2006)

No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

DEFAULT (JAN 2006)

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).

(2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

(b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.

(c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.

(d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.

(e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.

(f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.

(g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

State shall allow Contractor to defend such claim so long as the defense is diligently and capably prosecuted. State shall allow Contractor to settle such claim so long as (i) all settlement payments are made by Contractor, and (ii) the settlement imposes no non-monetary obligation upon State. State shall reasonably cooperate with Contractor's defense of such claim. (b) In the event an injunction or order shall be obtained against State's use of any acquired item, or if in Contractor's opinion, the acquired item is likely to become the subject of a claim of infringement or violation of an IP right, Contractor shall, without in any way limiting the foregoing, and at its expense, either: (1) procure for State the right to continue to use, or have used, the acquired item, or (2) replace or modify the acquired item so that it becomes non-infringing but only if the modification or replacement does not adversely affect the specifications for the acquired item or its use by State. If neither (1) nor (2), above, is practical, State may require that Contractor remove the acquired item from State, refund to State any charges paid by State therefor, and take all steps necessary to have State released from any further liability. (c) Contractor's obligations under this paragraph do not apply to a claim to the extent (i) that the claim is caused by Contractor's compliance with specifications furnished by the State unless Contractor knew its compliance with the State's specifications would infringe an IP right, or (ii) that the claim is caused by Contractor's compliance with specifications furnished by the State if the State knowingly relied on a third party's IP right to develop the specifications provided to Contractor and failed to identify such product to Contractor. (d) As used in this paragraph, these terms are defined as follows: "IP right(s)" means a patent, copyright, trademark, trade secret, or any other proprietary right. "Acquired item(s)" means the rights, goods, or services furnished under this agreement. "Specification(s)" means a detailed, exact statement of particulars such as a statement prescribing materials, dimensions, and quality of work. (e) Contractor's obligations under this clause shall survive the termination, cancellation, rejection, or expiration of this Agreement. [07-7B103-1]

LICENSES AND PERMITS (JAN 2006)

During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. MATERIAL AND WORKMANSHIP (JAN 2006)

Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be new and of the most suitable grade for the purpose intended. [07-7B120-1]

PRICE ADJUSTMENTS (JAN 2006)

(1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid

approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

- (a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
 - (b) by unit prices specified in the Contract or subsequently agreed upon;
 - (c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;
 - (d) in such other manner as the parties may mutually agree; or,
 - (e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35, Article 17 of the S.C. Code of Laws.
- (2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830. RELATIONSHIP OF THE PARTIES (JAN 2006)

Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any agreement with a third party or to incur any obligation or liability on behalf of the other party. [07-7B205-1]

RELATIONSHIP OF USING GOVERNMENTAL UNITS (JAN 2006)

Each Using Governmental Unit's obligations and liabilities are independent of every other Using Governmental Unit's obligations and liabilities. No Using Governmental Unit shall be responsible for any other Using Governmental Unit's act or failure to act. [07-7B210-1]

SHIPPING / RISK OF LOSS (JAN 2006)

F.O.B. Destination. Destination is the shipping dock of the Using Governmental Units' designated receiving site, or other location, as specified herein. (See Delivery clause) [07-7B220-1]

STATEWIDE TERM CONTRACT (FEB 2021)

(a) With this solicitation, the state seeks to establish a term contract (as defined in Section 11-35-310(35)) available for use by all South Carolina public procurement units (as defined in Section 11-35-4610(5)). Use by state governmental bodies (as defined in Section 11-35-310(18)), which includes most state agencies, is mandatory except under limited circumstances, as provided in Section 11-35-310(35). See clause entitled "Acceptance of Offers 10% Below Price" in Part VII.B. of this solicitation. Use by local public procurement units is optional. Section 11-35-4610 defines local public procurement units to include any political subdivision, or unit thereof, which expends public funds. (b) The State shall be entitled to audit the books and records of you and any subcontractor to the extent that such books and records relate to the performance of the work. Such books and records shall be maintained by the contractor for a period of three years from the date of final payment under the contract and by the subcontractor for a period of three years from the date of final payment under the subcontract, unless a shorter period is otherwise authorized in writing by the Chief Procurement Officer.

(c) Notwithstanding the "Purchase Orders" clause, a Using Governmental Unit may include additional contract terms in a purchase order if and to the extent necessary for the Using Governmental Unit (i) to comply with federal laws as are mandatorily applicable to an expenditure of federal assistance, grant, or contract funds, or (ii) to impose organizational, operational, or technical security measures designed to protect the integrity, availability, or confidentiality of the Using Governmental Unit's data. Additional contract terms may not be used if they involve an increase in pricing or materially alter the scope of work. TERMINATION FOR CONVENIENCE (JAN 2006)

(1) Termination. The Procurement Officer may terminate this contract in whole or in part, for the convenience of the State. The Procurement Officer shall give written notice of the termination to the contractor specifying the part of the contract terminated and when termination becomes effective.

(2) Contractor's Obligations. The contractor shall incur no further obligations in connection with the terminated work and on the date set in the notice of termination the contractor will stop work to the extent specified. The contractor shall also terminate outstanding orders and subcontracts as they relate to the terminated work. The contractor shall settle the liabilities and claims arising out of the termination of subcontracts and orders connected with the terminated work. The Procurement Officer may direct the contractor to assign the contractor's right, title, and interest under terminated orders or subcontracts to the State. The contractor must still complete the work not terminated by the notice of termination and may incur obligations as are necessary to do so.

(3) Right to Supplies. The Procurement Officer may require the contractor to transfer title and deliver to the State in the manner and to the extent directed by the Procurement Officer: (a) any completed supplies; and (b) such partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (hereinafter called "manufacturing material") as the contractor has specifically produced or specially acquired for the performance of the terminated part of this contract. The contractor shall, upon direction of the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.

(4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

(b) The Procurement Officer and the contractor may agree to a settlement and that the settlement does not exceed the total contract price plus settlement costs reduced by payments previously made by the State, the proceeds of any sales of supplies and manufacturing materials under Paragraph (3) of this clause, and the contract price of the work not terminated;

(c) Absent complete agreement under Subparagraph (b) of this Paragraph, the Procurement Officer shall pay the contractor the following amounts, provided payments agreed to under Subparagraph (b) shall not duplicate payments under this Subparagraph:

(i) contract prices for supplies or services accepted under the contract;

(ii) costs reasonably incurred in performing the terminated portion of the work less amounts paid or to be paid for accepted supplies or services;

(iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;

(iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under

Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

(d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.

(5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the State's right to require the termination of a subcontract, or (ii) increase the obligation of the State beyond what it would have been if the subcontract had contained an appropriate clause.

IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation. As provided in the solicitation, if a public procurement unit is offered the same supplies, services, or information technology at a price that is at least ten percent less than the term contract price, it may purchase from the vendor offering the lower price after first offering the vendor holding the term contract the option to meet the lower price. The solicitation used to establish the term contract must specify contract terms applicable to a purchase from the vendor offering the lower price.
